

Privacy Policy

This privacy policy covers gardenpathways.org and all online services provided by Garden Pathways, Inc. (“GP”).

For GP, protecting the personally identifiable information of visitors to this site is of utmost importance. Below you will find helpful information about our commitment to ensuring the privacy of your information, such as your full name, email address, telephone number, and other indentifying information. 1. Gathering of Information

We do not collect personally identifiable information from our visitors other than what is supplied to us on a voluntary basis when communicating with GP by e-mail. Visitors to gardenpathways.org may voluntarily supply certain personal information by e-mail, such as name, e-mail address, phone number, and message to GP.

2. Use of Information

GP will use the information it gathers from its online visitors only for the activities stated above. GP will never willfully disclose any personally identifiable information about our online audience to any third party without first receiving permission. The use of personally identifiable information is limited to the following: responding to user emails; sending communications, including promotional communications, from GP to those who have “opted in” to receive such communications, and other purposes specified at the time the information is gathered. Our visitors will recognize that under certain circumstances, if they elect to “opt out” of providing such information, they may not be eligible for certain activities for which the personally identifiable information is needed.

3. Browsers

Like all other web servers, GP’s web server automatically creates log files for each visitor who accesses our site. The use of website measurement software assists GP in analyzing the user experience on our website and improving the structure and ease of use of the site. It is used to collect such information as the number of unique visitors, how long visitors spend on our website, and common entry and exit points into and from the website. GP does not use “cookies” to collect information. However, some of the sponsors of our site may also use cookies in order to target information to users’ interests. 4. Security

GP has in place what we believe to be appropriate physical, electronic, and managerial procedures to safeguard and secure information we collect online.

5. Children

Children must be at least 13 years of age to submit information to GP. If you are under 13, do not send any information about yourself, including your name, address or email address. If we discover that we have collected any personally identifying information from a child under the age of 13, we will remove that information from our database as soon as possible.

6. Opt Out; Corrections to Personal Data

Please contact us to a) to opt out of future communications from GP, b) to correct or update any personal information in the gardenpathways.org's database that you state is erroneous, or c) to request GP to make reasonable efforts to remove your personal information from the gardenpathways.org online database.
